#### 1. To approve the minutes of Feb. 28, 2022:

- The office is having hornets and ants starting to appear Curtis will call Modern Pests.
- The staff could use more training on the web site Curtis will reach out to schedule.
- Phones in the office need to be updated we have 2 numbers, one to the office and one to the selectmen's office. We need phones that will ring in on either number, be able to transfer, and put calls on hold.

#### Roads –

- Plowing is difficult due to the weather extremes.
- RFP for paving should go out directly after the Town Meeting. Prices are increasing.
- o DOT sent a notice of ADA upgrades to crosswalk lights on 119 Hebron Academy.
- Bob had asked about getting a truckload of culverts it was suggested that Bob turn in a count of culverts that will be needed for the next two years.

### 4. Broadband

Elizabeth contacted ConnectME with questions on the grant and both Spectrum and GWI negotiations. GWI appears to have newer equipment which may last longer with better speeds. She sent a letter of support to GWI for the first round of grant monies. The grant decision should be made by the end of April. We are still waiting on Spectrum for updated wording in the contract they are proposing.

The board was notified that Glenn Holmes would represent the Town of Hebron on the Lake Auburn Water Commission for one year.
