Minutes**

1. CALL TO ORDER and FLAG SALUTE – *Chairman Butch Asselin presided. Selectman Elizabeth Olsen, Selectman Joey Chretien and Town Administrator Alicia Bryant were present.*
2. ACTION ON MINUTES – *Action on Minutes dated December 22nd, 2025 – Butch motioned to approve minutes dated December 22nd, 2025. Elizabeth seconded, 3-0.*
3. PUBLIC COMMENTS – *NONE*
4. BUSINESS ITEMS –
 - 4.1. Review and sign The Emergency Operation Plan – *Board reviewed the updates to The Emergency Operation Plan. Butch motioned to sign The Emergency Operation Plan. Elizabeth seconded, 3-0.*
 - 4.2. Review of Decembers monthly reports – *Board reviewed the monthly reports for December. Butch motioned to accept the December monthly reports. Elizabeth seconded, 3-0.*
5. TOWN ADMINISTRATOR UPDATES – *Alicia read an email from Robert Faunce complimenting the Highway Department this fall. Butch mentioned also seeing lots of positive comments on Facebook about the Highway Department this winter. – Alicia mentioned that there are three accounts going to foreclosure in February and wanted to bring it to the board's attention ahead of time in the event they wanted to wave foreclosure. One of the properties had recently been condemned. The board agreed that is something they would like the paperwork ahead of time before it does go to foreclosure. – Alicia mentioned MSAD 17 is holding a vote in February about the purchase of a building in South Paris for a new bus garage. They are currently holding tours of the current space and new space and would like board members from each town to attend. – Alicia gave the board some quotes for a new flag pole as requested during budget meeting. The board agreed to see if just a single part is replaceable, then go with that option and a new light. If a new pole is needed then will revisit.*
6. SELECTMEN ITEMS – *Butch mentioned that some towns recoup fire department calls by billing insurance companies. That is something he would like us to check into. Butch mentioned about having a warrant article about tax prepayment.*
7. SIGN WARRANTS – *Warrants #67, #68, #1 & #2 – Butch motioned to sign Warrants #67, #68, #1, & #2. Joey seconded, 3-0.*
