1. CALL TO ORDER and FLAG SALUTE – *Chairman Butch Asselin presided. Selectmen Elizabeth Olsen, Selectmen Joey Chretien and Town Administrator Alicia Bryant were present.*

5. TOWN ADMINISTRATOR UPDATES – *Alicia gave a reminder that the Town Office will be closed for Presidents' Day. – Gave an update on the foreclosures, one did come in to pay. Other two still out standing but usually come into pay right before. – Alicia gave an update on the flag pole, noting that we will not know what part needed to be replaced until spring. – Alicia mentioned receiving a bill for the telephone pole from the December 19 incident, and got them to drop the price. Board stated to reach out to insurance even though no damage was done to cover cost of the pole. – Alicia gave an update about receiving the deed to the Town Office. – Alicia asked who is going to sign the road posted signs. Board discussed and suggested Town Administrator to sign. Elizabeth motioned that the Road Commissioners approve the Town Administrator to sign the road posted signs to be put up by the date the Road Foreman suggests and coordinates with surrounding towns. Butch seconded, 3-0.*
6. SELECTMEN ITEMS – *Butch asked for an update about agreement with the Town of Oxford regarding bringing our cardboard and updating our brush agreement. Alicia gave an update where we were at and mentioned reaching out again to move forward with this. – Butch asked about the cover photo for the Town Report. Alicia asked more details regarding the photo as wanted to make sure it was okay to use it and give proper credit.*
