SELECTMEN'S MEETING**

**February 23<sup>rd</sup>, 2026 6pm  
Minutes**

1. CALL TO ORDER and FLAG SALUTE – *Chairman Butch Asselin presided. Selectmen Elizabeth Olsen, Selectmen Joey Chretien and Town Administrator Alicia Bryant were present.*
2. ACTION ON MINUTES – *Action on Minutes dated February 9<sup>th</sup>, 2026. – Elizabeth motioned to accept minutes dated February 9<sup>th</sup>, 2026. Joey seconded, 3-0.*
3. PUBLIC COMMENTS – *NONE*
4. BUSINESS ITEM –
  - 4.1. Review and sign election clerk appointments – *Elizabeth motioned to sign election clerk appointments for Sherry Drake and Teresa Grover.*
5. TOWN ADMINISTRATOR UPDATES – *Alicia mentioned how the school is booked for the town meeting and that we have Vern scheduled for the moderator. – Alicia spoke about Josh Hounsell's interest in restarting the Rec committee up again. Board discussed and believe there is no need at this time for a committee. As the Highway department has been doing the maintenance and we have a Town Administrator now and if things are needed or someone has a plan, they can bring it to the board or Town Administrator to review/carryout. – Alicia gave an update on foreclosures on back taxes, two of the three have been paid and have been talking to the third and believe it will be taken care of, tomorrow is the last day. – Road posted signs have all be signed and dated for March 1<sup>st</sup> and the Highway Department will be working on getting them up all week. – State revenue predictions have come in for 2027 looking at \$181,651, subject to change. Up from \$167,999 for 2026.*
6. SELECTMEN ITEMS – *Elizabeth asked if there was any interest in the open Highway Department position. Board had a discussion about the needs for the Highway Department and where to put it out there about the open position, possible job fairs, even checking into paying for a CDL class. – Butch asked for an update on the Transfer Station. Alicia said she had met with Adam today, and they had come to an agreement about extending the current brush/yard waste agreement and he agrees with bringing the cardboard there with the understanding if anything changes financially that both parties review the agreement. Alicia is going to draft up an agreement and send it out. – Butch questioned any notice of Mid Maine Waste raising their prices, he saw it in the sun journal. Alicia and the board agreed we had signed a 5-year contract in September with the first year locked in on price and years 2-5 have a CPI adjustment, also noting that we are a municipality so it is different than the haulers. Joey noted we are not part of the primary group member so we are paying more than them. Minot, Auburn, and Lewiston are the primary member and get a reduce rate, which will be going up along with other non-contracts.*
7. SIGN WARRANTS – *Warrants #9, #10 & #11– Butch motioned to sign Warrants #9, #10, #11. Elizabeth seconded, 3-0.*
